# **TRENT WINN SCHOLARSHIP FUND**

### **Application Form**

**Designation of Purposes:** The Trent Winn Scholarship Fund for education was established for the purpose of providing financial assistance to students with a certificate or degree in a Skilled Trade School. The scholarship is paid to the college, university or program (non-taxable). The award can be used for books, tuition, and housing expenses. Students eligible are those who have graduated from the **Wexford-Missaukee Career Technical Center** or have received their GED and wish to attend a Skilled Trade School.

**Eligibility:**

- a. Graduated senior or received a GED from Wexford-Missaukee Career Technical Center
- b. Shows financial need, skill, ability, and desire to complete a degree or certificate in their chosen field of Skilled/Technical Trades.

Amount: \$1250

**Fund History:** About Trent Winn

This fund was established in 2014 by Trent's wife, Brenda and his children, Kylee and Abby Winn, to honor the memory of their husband and father. Trent was an extremely active parapalegic that did not let life get in his way. Trent was not a "typical" student and struggled in a classroom setting, but excelled in his search for a career with the construction trade. Throughout Trent's life, he continued to be an advocate for non-traditional schooling and in order to continue his devotion to the trades, the Trent Winn Memorial Scholarship Fund was created.

\*If you are a CURRENT HIGH SCHOOL STUDENT: Submit your most recent TRANSCRIPT, ACT, and/or SAT WITH SCORE REPORTS.

\*If you are a HOMESCHOOL STUDENT: Submit your letter of acceptance from your chosen college.

\* ONE PAGE, TYPED, SINGLE SPACED, USING A 12-POINT FONT, PERSONAL ESSAY introducing yourself, describing your course of study in college and career choice you are finished with school. Also, include how you may have grown and learned from personal or family challenges, i.e., health, financial, etc., that you consider pivotal to your maturing. Please close your essay describing where you see yourself in 5 years.

Academic Achievements – Please list extraordinary academic achievements such as membership in particular societies, advanced classes, awards, or any other academic recognition type. (i.e., National Honor Society, Membership in Trade Associations, etc.) Please limit your response to the last 2 years.

Leadership –List positions of Leadership that you have held. (i.e., Class officer, Sports Teams, Clubs, Church). Please limit your response to the last 2 years.

Service – List examples that demonstrate your actions, with or on behalf of others, without any direct financial or material compensation. Service contributions to scouts, school, clubs, committees, classmates, church, and community at large will all be considered. Please limit your response to the last 2 years.

Character – List examples of your behavior that demonstrate the qualities of respect, responsibility, trustworthiness, fairness, caring, and citizenship. Please list employment, school activities, and special recognition. Please limit your response to the last 2 years.
